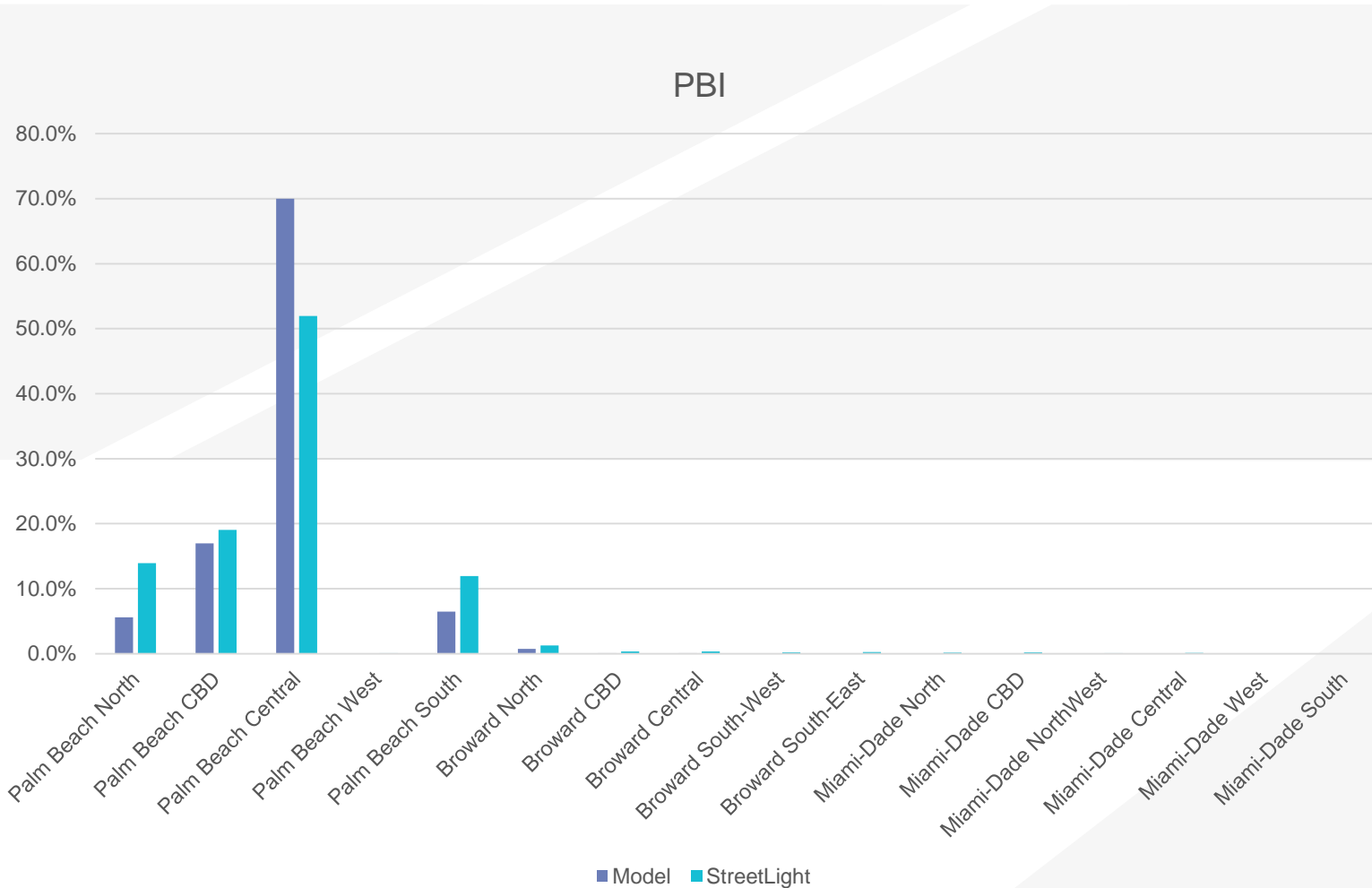
→ Time periods

$$\text{Utility} = -0.18226 * \text{Travel Time} + \text{Size}$$

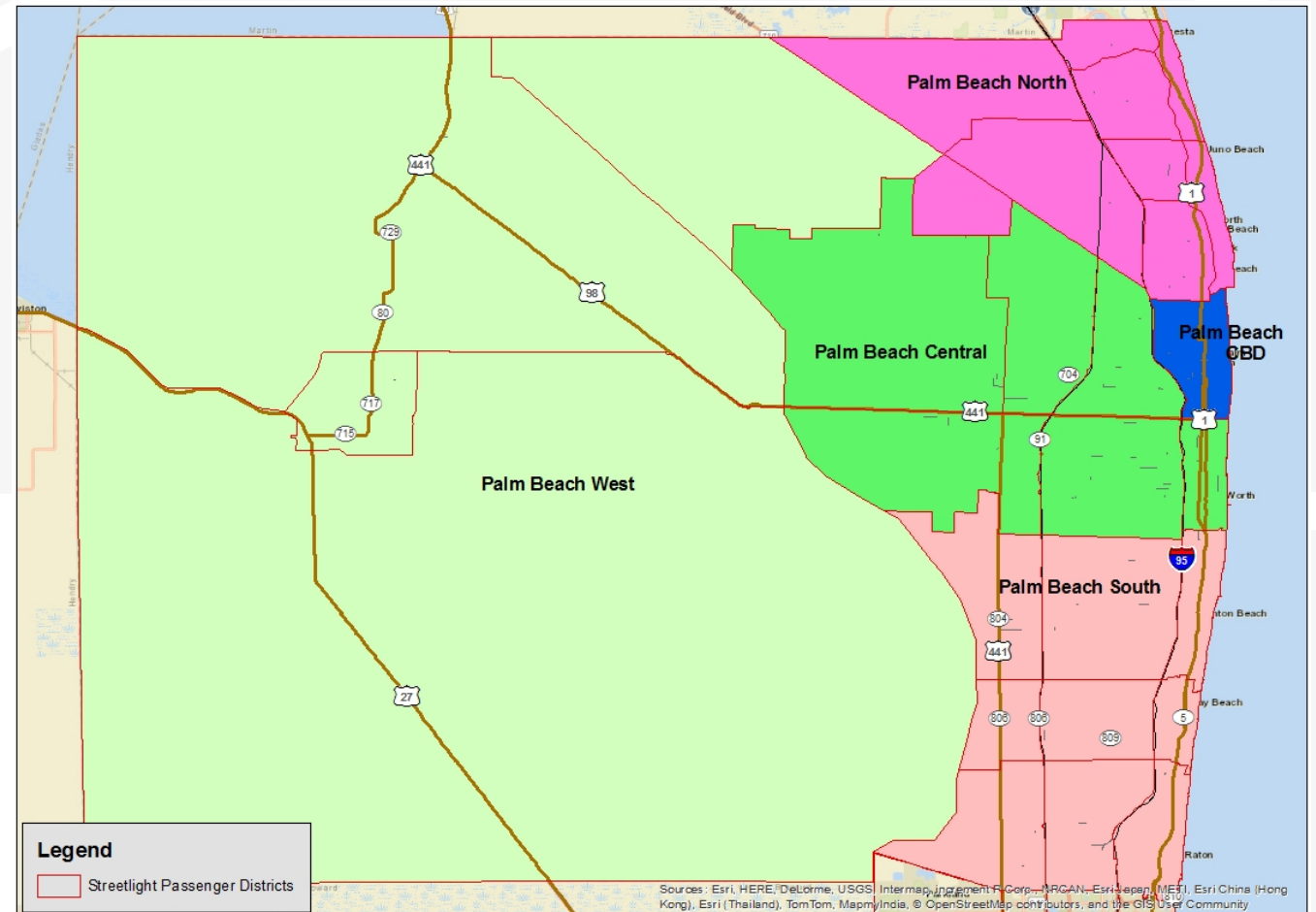

Super Districts: Palm Beach County

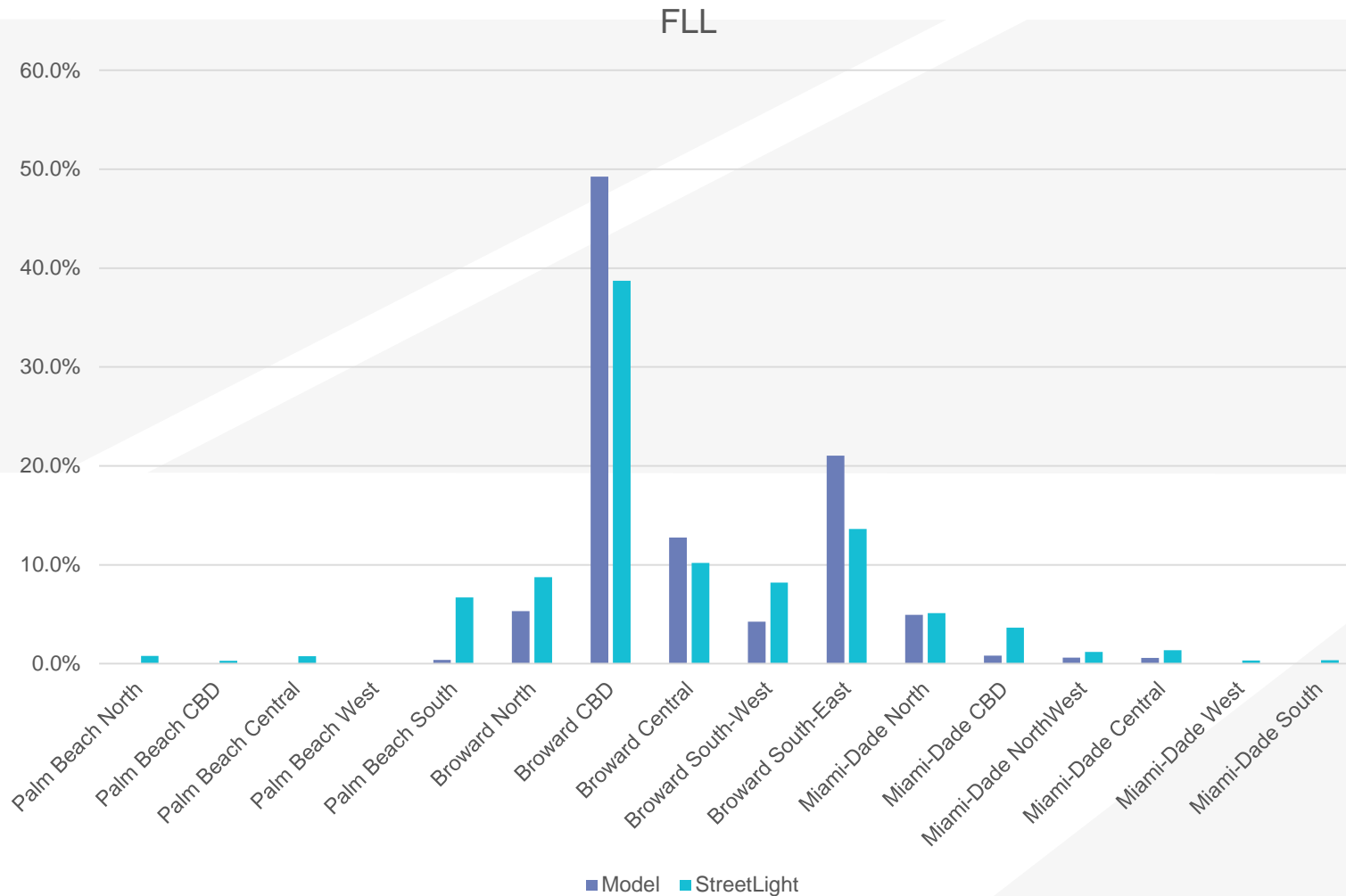
Palm Beach County can feature five districts:

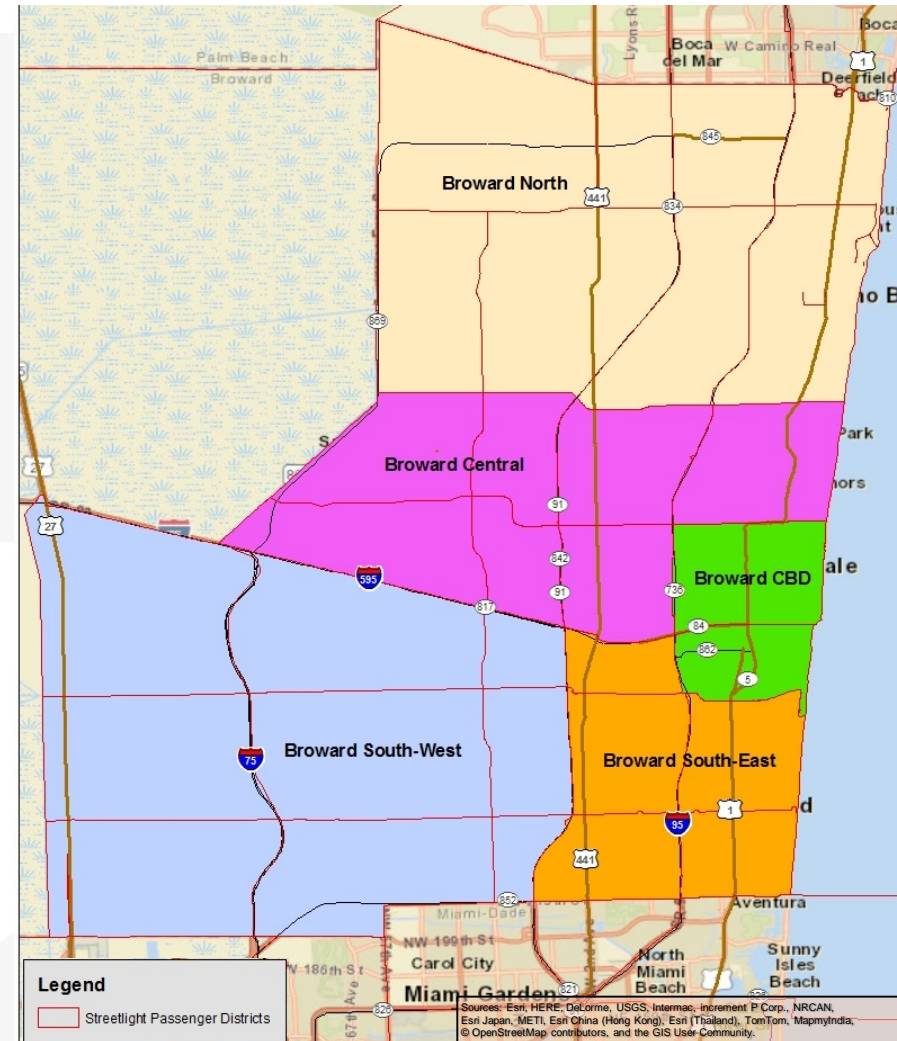

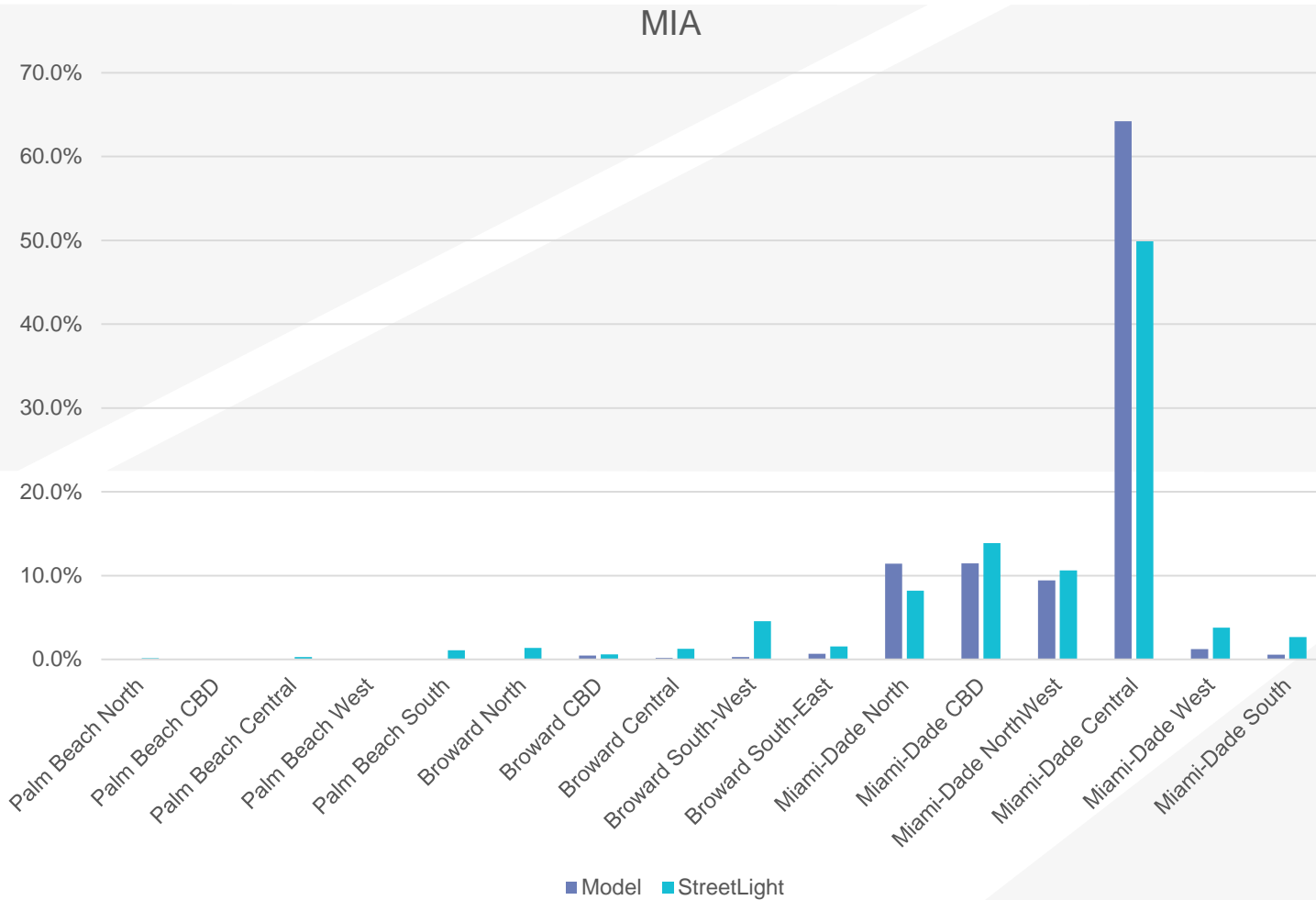
Broward County can feature five districts:

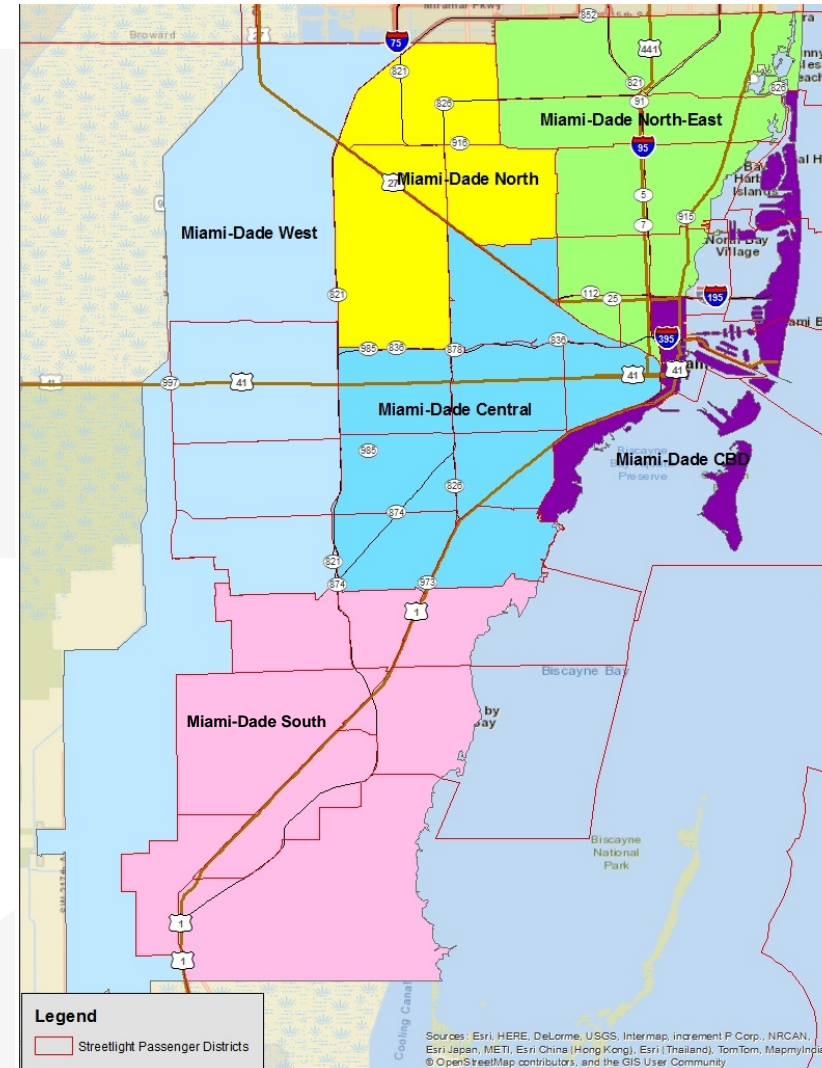

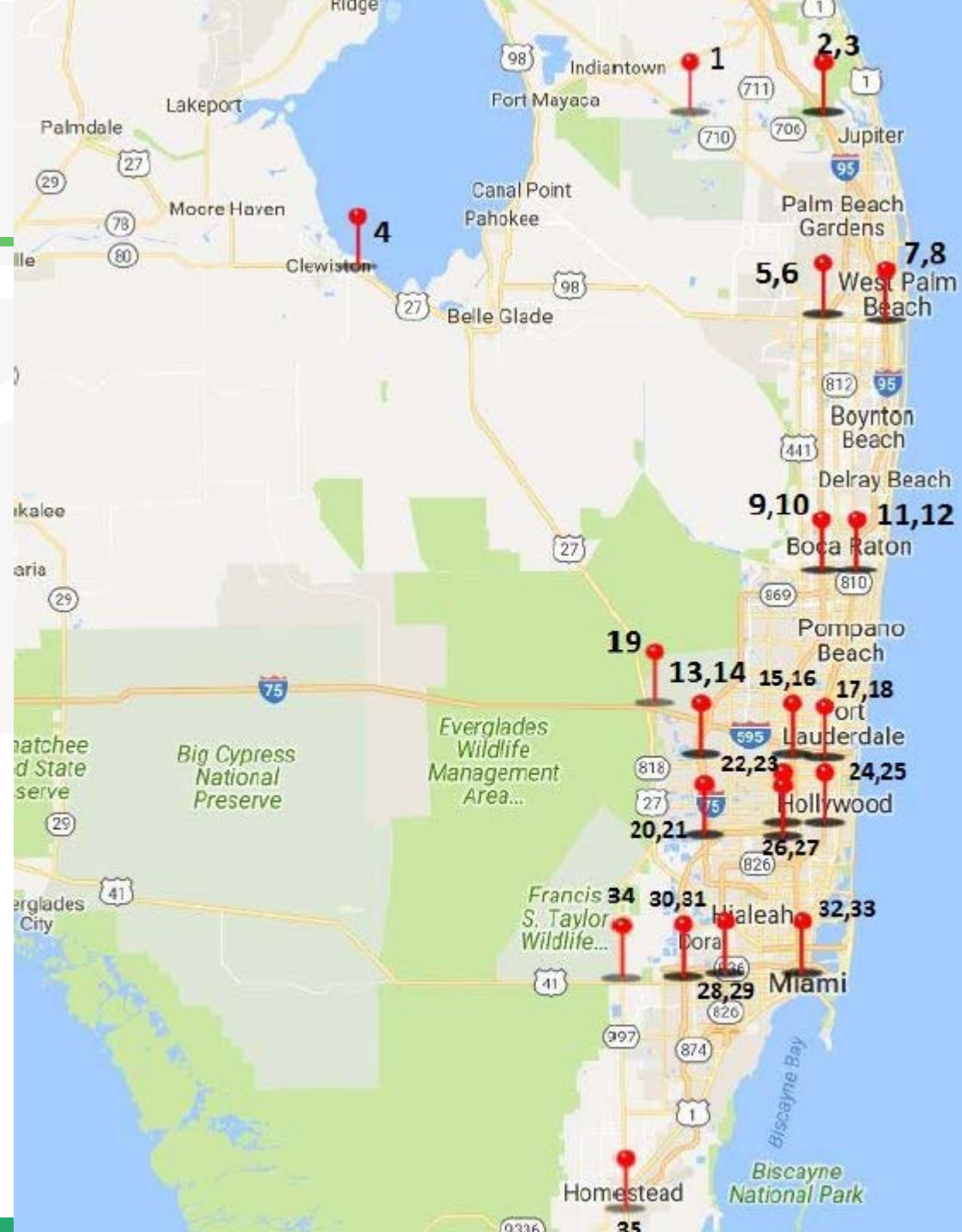
Super Districts: Miami-Dade County

Middle Filters

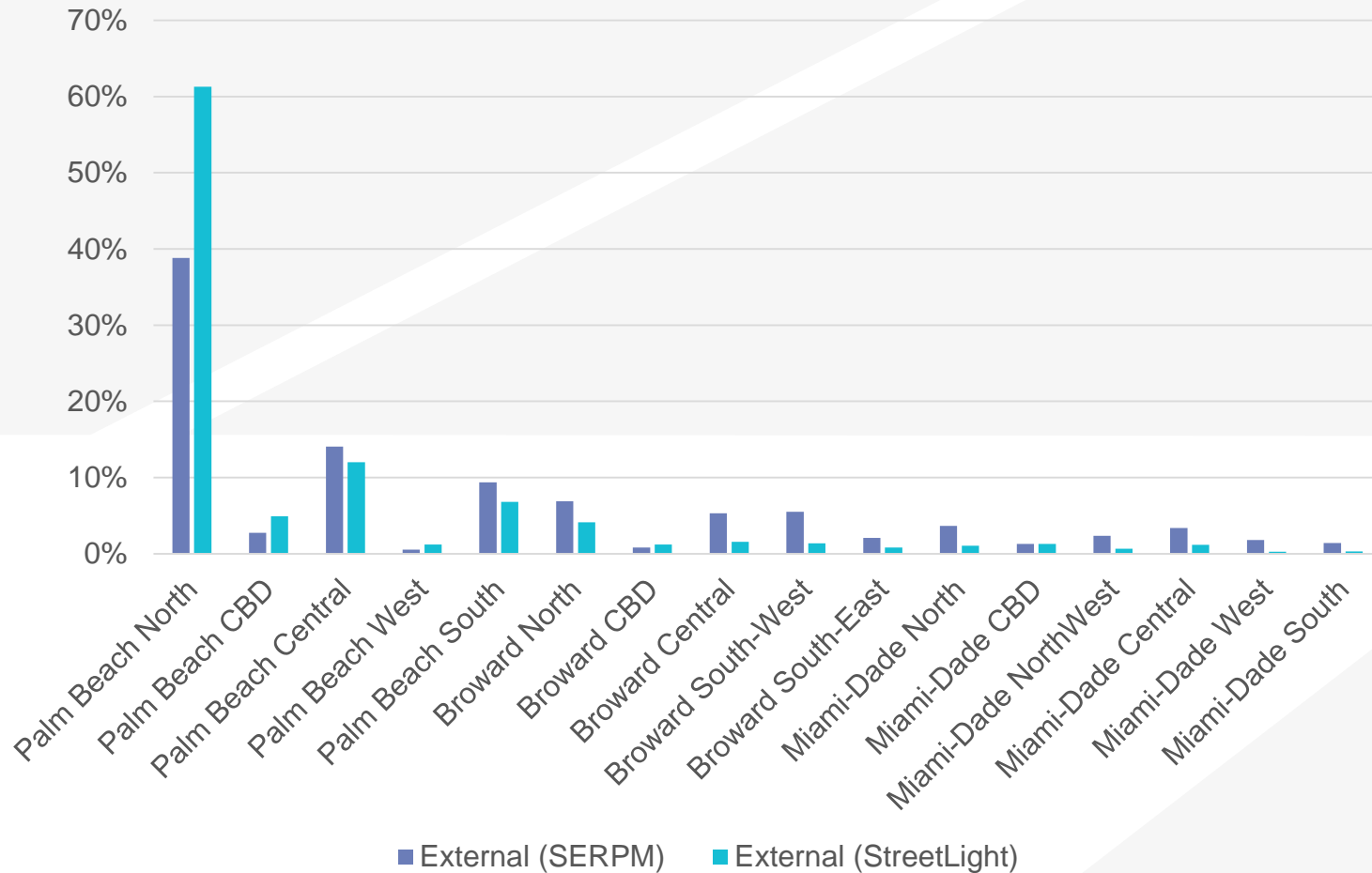


External Station Splits

 - » Not all external areas are zones

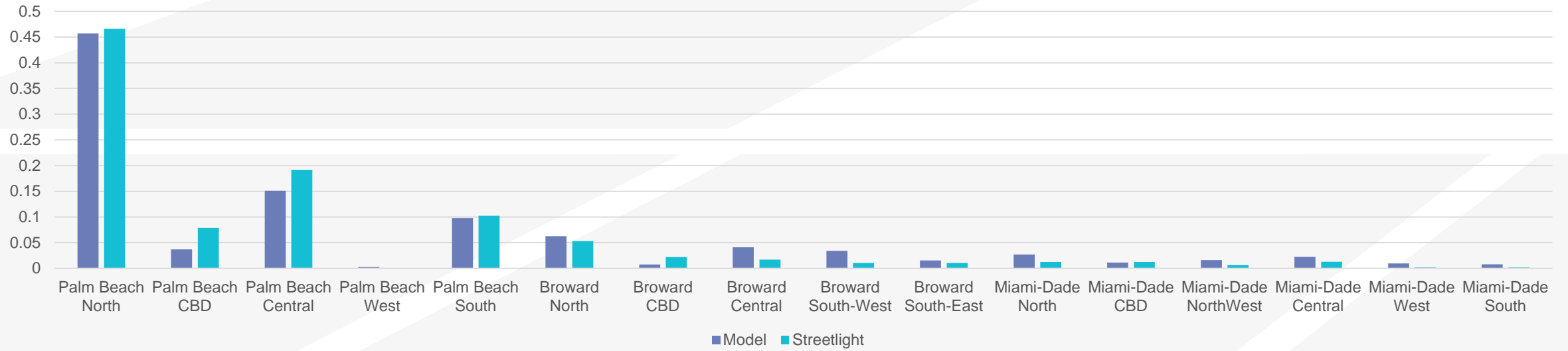
External Person Trip Distribution

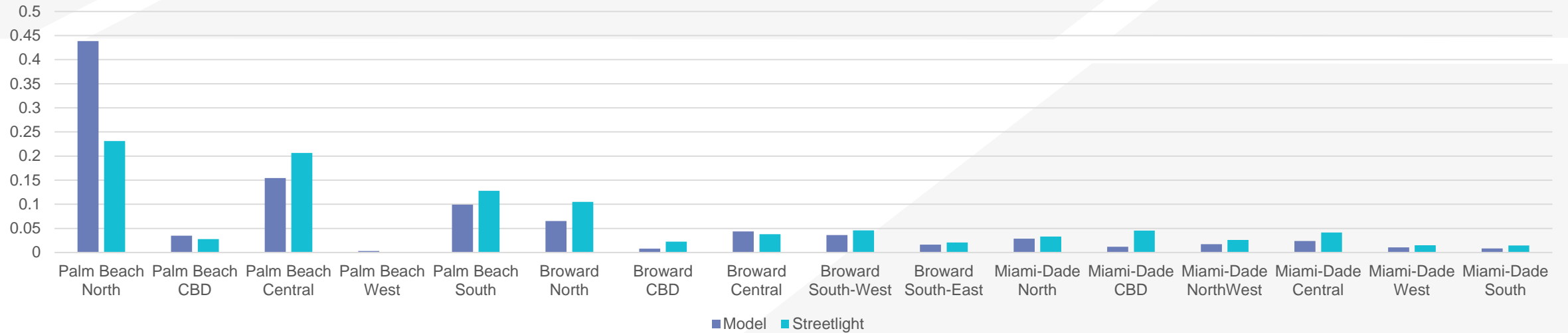

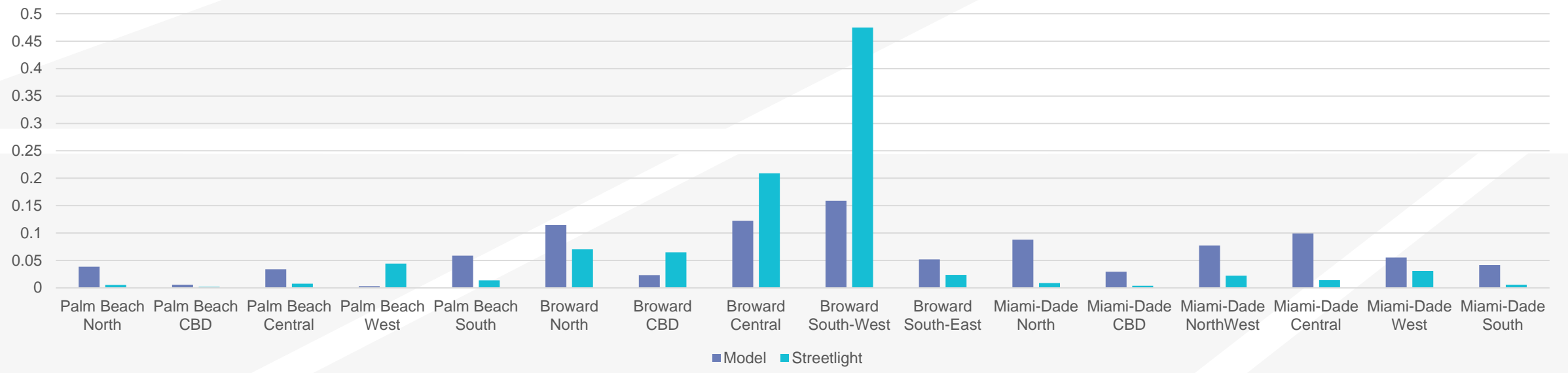

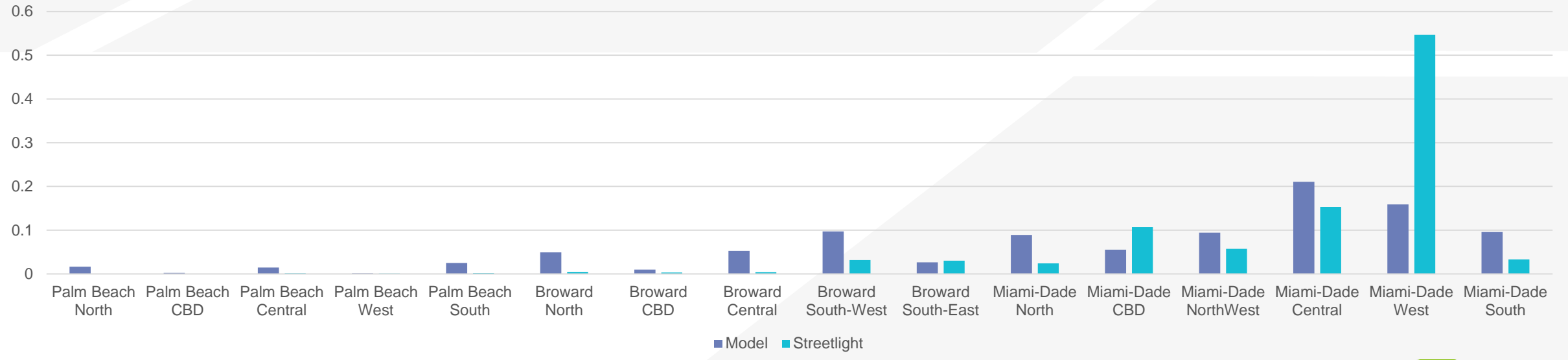

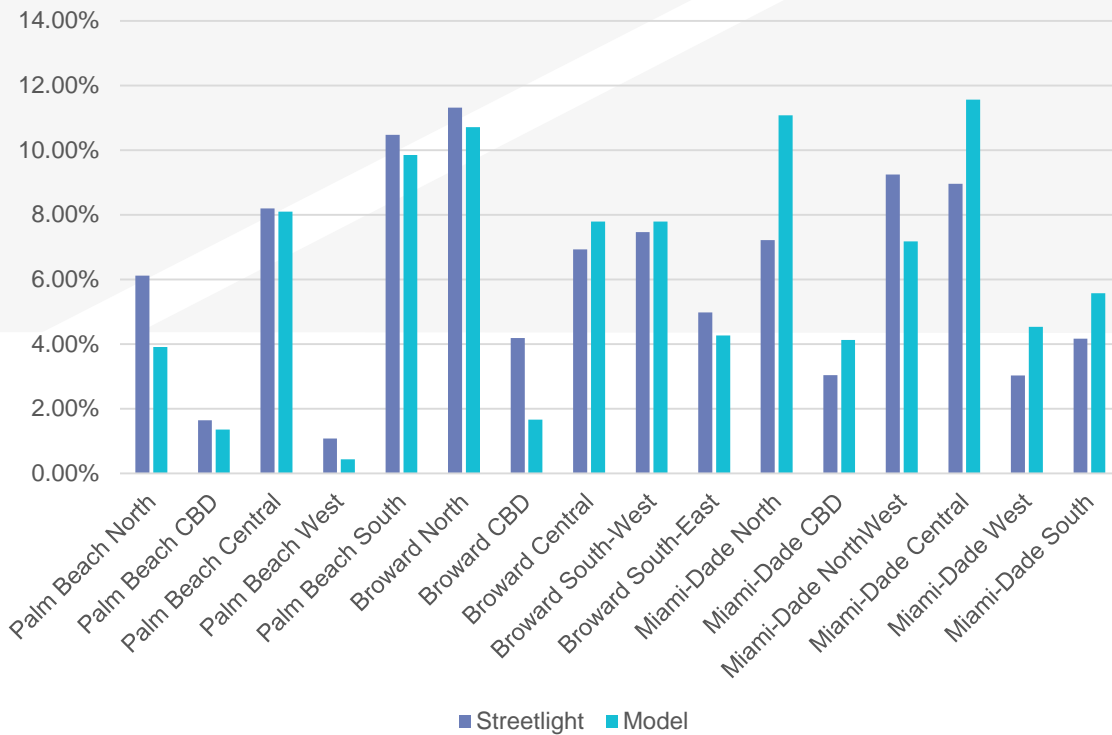

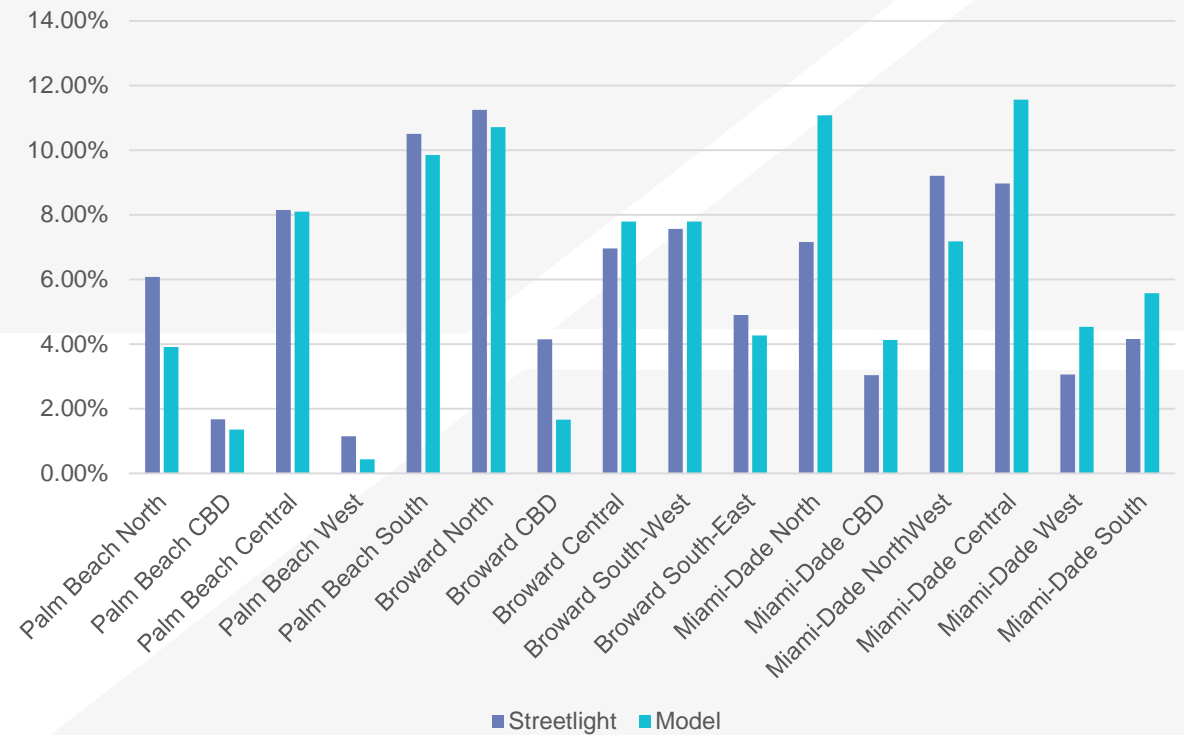


Internal Medium Truck Distributions

Truck Origin Share

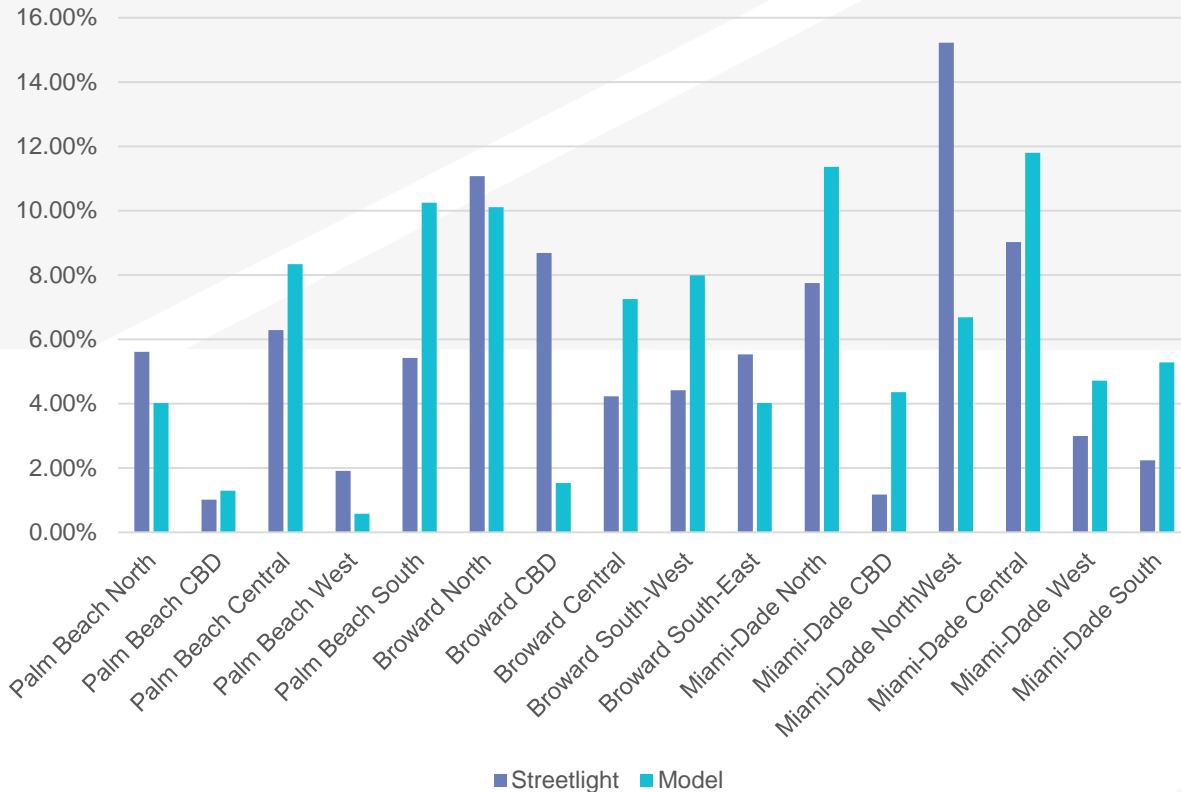


Truck Destination Share

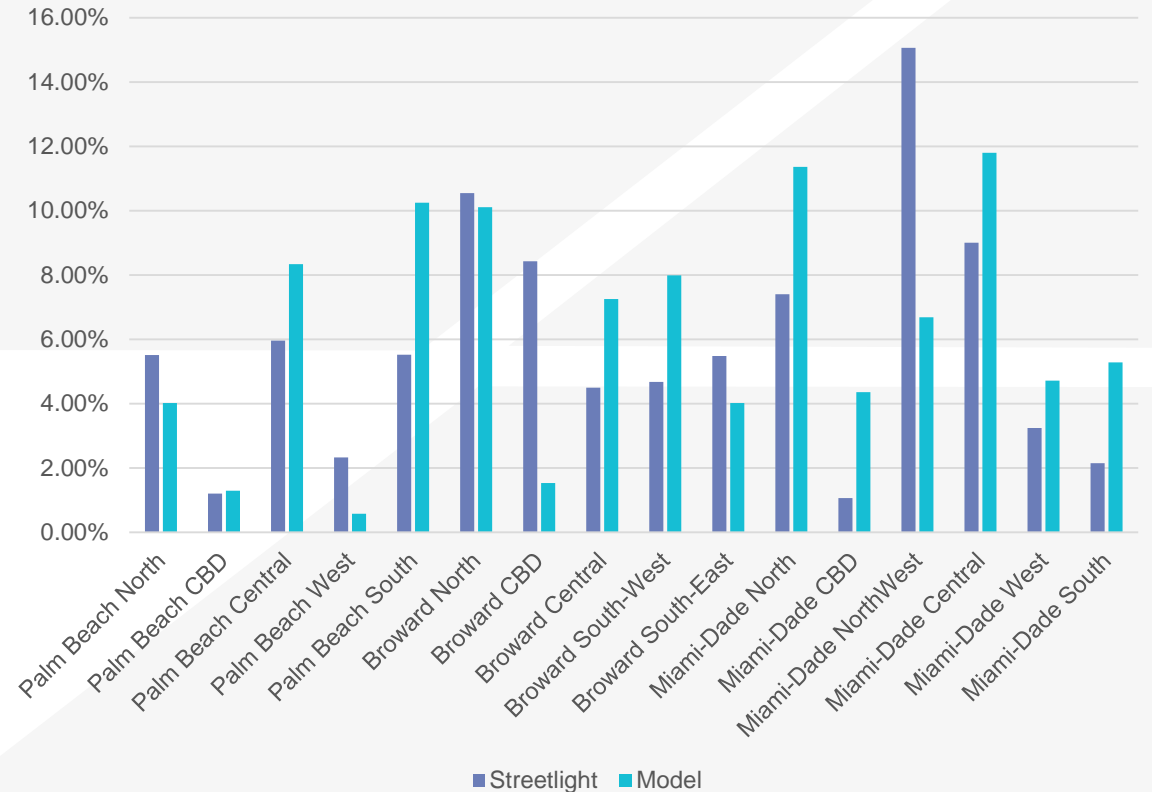


Internal Heavy Truck Distributions

Recommendations

- TOD
 - » Utilize roadway count stations to update TOD
- Airport
 - » Calibrate time term to better fit super district distributions
- EI
 - » Confirm Turnpike EI distribution
 - Calibrate to Streetlight
 - » Calibrate I-75, US 1 EI distributions
 - » Recheck overall distribution by super district
- Trucks
 - » No changes for initial SERPM 8
 - » Distribution differences highlight need for a closer look at the freight/truck model
