Data Committee



- April 4, 2012
- The purpose of the teleconference was to provide comments regarding the U.S. Census Bureau's American Community Survey and to provide an overview of the Statement of Purpose that will be developed for the State of Florida Household Travel Survey.



Data Committee



- April 18, 2012
- The purpose of the teleconference was to start development of a “Statement of Purpose” for the State of Florida Household Travel Survey.



Data Committee



- April 25, 2012
- A five member subcommittee of the Florida Model Task Force’s Data Committee participated in a conference call to begin initial development of a Statement of Purpose for the State of Florida Household Travel Survey.



Data Committee



- May 8, 17, and 22 2012
- Teleconferences with the subcommittee of the Data Committee to review and provide changes to the “Statement of Purpose” for the State of Florida Household Travel Survey.



Data Committee



- May 31, 2012
- The purpose of the teleconference was to review the “Statement of Purpose” for the State of Florida Household Travel Survey and recommended some changes be incorporated and that the Data Committee be surveyed concerning the recommendations identified in the Statement of Purpose regarding a Household Travel Survey for the State of Florida.



Data Committee



- June 15, 2012
- The purpose of the teleconference was to review the Statement of Purpose for the Household Travel Survey developed by the subcommittee. The Data Committee was pleased their comments were incorporated from the previous Data Committee meeting and authorized the Statement of Purpose to be sent to the Florida Model Task Force Tri-Chairs for review.



Data Committee



- August 14, 2012
- Data subcommittee reviewed changes on the Household Travel Survey Statement of Purpose offered by the Transit Committee Chairperson. Most of the changes were incorporated and the revised Statement of Purpose was sent to the Florida Model Task Force Tri-Chairs and the full Data Committee on August 16, 2012.



Land Use Committee



- August 15, 2012
- The Land Use Report Phase II draft “Integrating FSUTMS & Land Use Forecasting Analysis Tools” was received by Committee Chairperson.



Land Use Committee



- August 16, 2012
- Committee Chairperson provided comments on Land Use Report Phase II draft “Integrating FSUTMS & Land Use Forecasting Analysis Tools” to FDOT and their Consultant.



Land Use Committee



- September 27, 2012
- The purpose of the teleconference was to provide any comments or changes on the Land Use Report Phase II draft “Integrating FSUTMS & Land Use Forecasting Analysis Tools.” A recommendation was that an Appendix Check List be added at the end of the report and the draft report be sent to the Land Use Committee Members towards end of October 2012 for final comments and presentation occur at the Model Task Force Meeting in December 2012.



Land Use Committee



- October 22, 2012
- A copy of the Land Use Report Phase II draft “Integrating FSUTMS & Land Use Forecasting Analysis Tools” that incorporated the Land Use Committee’s comments from September 27, 2012 conference call was received by Committee Chairperson from FDOT’s consultant.



Land Use Committee



- October 24, 2012
- The report was forwarded to the Land Use Committee members by FDOT indicating that the Land Use Report Phase II draft “Integrating FSUTMS & Land Use Forecasting Analysis Tools” will be presented for action at the December 2012 Model Task Force Meeting.
